

Quality of Education

Committee Terms of Reference 2024 – 2025

1. MEMBERSHIP:

The committee shall consist of:

- At least four Governors including the Headteacher
- Co-opted non-voting members as appointed by the Governing Body
- The Clerk to the Governors

The Committee shall elect its own Chair at its first meeting and the College shall be represented by the Headteacher and any other members of staff as considered appropriate by the Headteacher, but those persons will not be entitled to vote, unless they are a Governor.

2. QUORUM:

The quorum shall be three members of the Governing Body.

3. MEETINGS:

The committee shall meet at least once per term; routinely 3 times per academic year, and otherwise as required.

All meetings are to start and end with a prayer.

4. TERMS OF REFERENCE:

This committee will support the Christ the King Strategy and Vision by:

- Ensuring that Christ the King College will be recognised for setting the highest standards of teaching and learning, where aspirations and achievements are raised.
- Ensuring that Christ the King College students grow up as determined, courageous and humble individuals who embody the gospel values throughout their lives with a deep appreciation of the beauty of God's world around them.

To achieve this, the Committee will:

- Relentlessly focus on consistently improving outcomes for all pupils.
- Consider the Headteachers Termly Report on Teaching and Learning in depth. Governors do not shy away from challenging leaders about variations in outcomes for student groups and between disadvantaged and other students nationally.
- Receive reports from the Headteacher concerning the departmental staffing of the College.
- Monitor and evaluate examination outcomes and the analytical and statistical data on student attainment and progress provided by the Headteacher and members of the Senior Leadership Team including outcomes for disadvantaged groups.
- Contribute to the discussion on Annual College Development Plan.
- Receive and consider reports on Governors Link visits to departments.
- Receive and consider reports from external advisors in relation to Teaching and Learning
- To Act as an In-Year Admissions Committee
